September 9	Entries may be delivered by artist to the Lodge at Angel Fire Resort 9am to 2pm
September 10-12	Artwork will be on display at the Lodge at Angel Fire Resort coinciding with hours of the 2010 Paranormal Symposium
September 11	Evening reception for artists and guests from 5pm to 7:00pm
September 13	Artists must pick up artwork at First National Bank from 1 pm to 5pm
September 14	Shipped artwork will be returned to artist

Artwork not picked up by designated times **must** be picked up at ArtSpace Gallery in The Inn Center at the gallery owners' convenience. There will be a \$10/day storage fee for artwork not picked up at the designated time.

Rules

All Artwork will:

- be the original creation of the artist depicting the show theme "Illusions".
- be the original artwork of the artist. Giclee's will not be accepted.
- have been produced within the last two years.

2 Dimensional Works shall:

- not exceed the framed size of 30x36 inches in any direction.
- be gallery quality matted and framed.
- be ready for hanging with a **WIRE** firmly attached (pulled taut) to the back of the artwork.

3 Dimensional work will be accepted in this year's MVAC themed exhibition Illusions.

3-D work may be in wood, clay, papier mache', metal or mixed media *provided it does not weigh more than 50 pounds and not exceed 24" x 24" by 36" high*. All sculpture or ceramics submitted must be able to be displayed on a table or come with its own pedestal for purposes of display.

Two to three digital images showing various views of your work should be submitted for each piece entered. These images should be labeled with Title of Work and A through C. If you are providing a pedestal one of these three images should show the piece as displayed. In the case of shipped work that must be assembled comprehensive instructions for assembly are required and should be considered before submission.

Entries

Entry fee: \$20 per piece. MVAC Members pay \$15 per piece. Get the Membership application at www.morenovalleyarts.org SAVE! Submit three pieces and get \$5 off the total

- Artists must submit their entries in digital form on a CD (the CD will not be returned)
- The images on the CD must be in JPEG form
- The size of the images on the CD must be 6x8 with a 300 resolution
- Artists name must be on the front of the CD
- Title and size of the images must be on the front of the CD in order of appearance
- Artist's 2010 Release Form must be signed and enclosed with entry
- Title and theme form must be filled out and returned
- Artist will include the entry fee and a return stamped/addressed envelope with the CD
- A check for the entry fee must be enclosed with the CD in the total amount due.

Entries must be received by the July 20 deadline. No late entries will be accepted.
